Counsel for the Resolution Professional is present and prayed for exclusion of 129 days out of maximum period of CIR process provided under Section 12 of the IBC, 2016. It is submitted that the CIRP was initiated on 06.09.2019. On 04.03.2020, an extension of 90 days was given. However, due to the commencement of the lockdown w.e.f. 25.03.2020 up to 31.05.2020 and the restrictions thereafter during the month of June and July, it was not possible for the Resolution Professional to utilize said period for make progress in the CIRP. The CD's assets are situated in Noida and there were restrictions in relation to the movements, due to which, the necessary steps could not be taken to make progress in the CIR process. It is also placed on record that the Form-G has been issued twice and the Resolution Plans are yet to be received.

Heard the counsel for the Resolution Professional and considered the Application. In the facts and circumstances stated in the Application and the additional affidavit, a period of 129 days is hereby excluded from the maximum period of 330 days of the CIRP with the direction to the Resolution Professional to expedite the process for receiving the Resolution Plans for the Consideration of the COC. In case, until the expiry of the maximum period of the CIRP, no Resolution Plan is submitted by RAs for the consideration of the COC or in the event no Resolution Plan is approved by the COC, then the Resolution Professional shall file the Application with all details for liquidation of the CD.

In terms of the above, the Application is **allowed**.
